



Hi,

This will be a link in the Discussion where Ms. Pritchard asked her excellent questions and it will also be a link in the email to you all in Blackboard Course Messages.

1. First things, I am so sorry that I blew it and that your class became a user test for Fact-Checking. I cannot undo the lost time and frustration, but I have made these attempts to show **my regret**:
  - A grade APOLOGY EVIDENCE DRAFT-1 – It has 25 extra credit points already entered.
  - A grade APOLOGY EVIDENCE DRAFT-2 – If you do Part 2: Fact-Checking, I will enter another 25 extra credit points.
  - And if the 2<sup>nd</sup> extra credit helps some or all of you persist, I have no problem doing a 3<sup>rd</sup>. I am **really** sorry.
2. Right now you can see the feedback on your Evidence Draft.
  - a. Click on My Grades.
  - b. Scroll down to Part 1: Evidence Draft
  - c. Click on the  Blackboard then displays what I wrote to you. **Tip**: It may be similar to this one because this one has comments to 3 or 4 students mixed together.

Also you can improve with the next 2 assignment and that can overwrite this grade. The numbers of the Requirements are in the Requirements link at the Draft folder. That will help you get stronger.

Requirement problems: 9 (do the heading the way someone asks). 5a, b, c or d, e (no secondaries) 7a-c (No primaries)

Good Habits for Evidence problems: Reading and writing passively (Habit 2). Plagiarizing or "half-copy" plagiarizing (Habit 4). This is danger to your future side by side with the sources. You did not write, but just typed.

3. Look at the example above. You are expected to do these same things for the other student:
  - a. Requirements problems. Those are followed by numbers from the Requirements link in the folder.
  - b. Good Habits for Evidence problems. Those have a number, either Habit 1, 2, 3, 4, and 5.
4. The Fact-Checking folder is immediately below the Evidence Draft folder. **Tip**: Evidence Draft is now Read Only.
5. **Caution**: Do **not** click on Discussions to do this work.
6. The Fact-Checking folder will open Sunday at 8:00 AM.
  - At the top of the folder, the instructions for 100 points for fact-checking 1 paper
    - What you need to cover about Requirements
    - What you need to cover about Good Habits for Evidence
    - How you enter your feedback so it is readable to everyone
  - Aid to help you with the Requirements
  - Aid to help you with the Good Habits for Evidence
  - The Fact-Checking discussion with your papers exactly as they were in Evidence Draft

After I am sure you guys are OK, I will update your List of Due Dates for when Part 2: Fact-Checking is due and when Part 3: Final Evidence Paper is due.
